SUPERINTENEDENT'S REPORT

DISTRICT GOAL #1: <u>Technology</u>: to support teachers in best practices that utilize available digital tools by becoming google ready (incorporating a variety of google apps), enhancing instruction through the use of interactive tools, home-to-school connections through enhanced teacher learning sites, and curriculum integration of computer science, design thinking, career readiness, life literacies and key skills standards.

Technology Tuesday PD sessions are scheduled and made available for all staff members. These optional mini (½ hour) PD sessions provide additional support with remote/hybrid learning and technology. Kami training (digital classroom) was conducted on 3.31.21.

The school administration continues to support teachers in the use of educational and learning platforms. The technology department continues to support and troubleshoot an and all related technology issues.

A monthly Curriculum Connections newsletter continues to be published and shared with all staff. A professional resources link is provided to support instruction through the Hybrid and All Remote learning models.

DISTRICT GOAL #2: <u>Professional Growth and Instructional Practices</u>: to build the capacity of all PK-12 instructional staff by supporting and fostering sustained professional growth in equitable practices in education to include culturally responsive teaching practices, LGBTQ curriculum, social-emotional learning (SEL)/ trauma Informed practices, Sheltered English Instruction (SEI) and response to intervention (RTI) to ensure engagement of the students and the community.

The Sheltered English Instruction (SEI) training has been launched. Staff members have begun to complete the 15-hour training course. Completion certificates will be submitted and filed with the curriculum office. This training will allow our staff members to better serve our ELL population.

Monthly curriculum meetings are being held in each of the three schools which focus on equitable practices and include culturally responsive teaching practices.

We have completed the ERNJ's Network for Educational Excellence through Equity (E3) training program for Equity team members. Each member completed 3-4 trainings throughout the year. The final district leader training will take place on April 22nd. Turnkey lesson learned will be shared and strategies applied beginning in September.

DISTRICT GOAL #3: <u>Health, Safety and Security:</u> We will continue to expand on our preparation, training, programming and facilities to ensure a safe and secure environment for all students, staff and visitors. Given the current health related crisis (COVID-19) we will increase our focus on establishing and maintaining a clean and safe environment for students, staff members and visitors to the school district.

As the School Safety Specialist I completed a refresher *Stop the Bleed* training in March and received 10 free Stop the Bleed kits for our school district. As a follow up I met with our SRO to determine where these kits would be strategically placed throughout the district. This information has been share with Administration, with a follow up to school staff. We are planning to have all administration and coaching staff members receive a refresher training on *Stop the Bleed* in September. All other staff will have training in follow up (small group) faculty meetings.

We continue to complete our safety drills as recommended by the NJDOE. I attend monthly drill webinars presented by the Office of School Preparedness and Emergency Planning. The most recent training recommended a Shelter in Place to a Level II lockdown (verbal only). The April drill is to be determined.

The Maintenance Department continues to do a very good job of keeping our facilities, classroom and offices clean and disinfected.
