**Authorize The Submission Of Two Bond Proposal Questions To The School District Voters At A Special School District Election To Be Held On January 24, 2023**

On the motion by Mrs. Winerling, seconded by Ms. Koka, and carried unanimously, Be It Resolved that The Board of Education of the Township of Riverside in the County of Burlington, New Jersey (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed by the Board) (not less than a majority of the full membership of the Board concurring) as follows:

1. It is hereby determined that the following two bond proposals (the "Proposals"), together with an explanatory statement (the "Explanatory Statement"), shall be submitted to the legal voters of the School District at a special School District election (the "Election") to be held on Tuesday, January 24, 2023 commencing at 6:00 a.m. for the purposes hereinafter provided. The polls shall remain open until 8:00 p.m. and as much longer as may be necessary to permit all the legal

voters then present to vote and cast their ballot. The form of the Proposals, together with the Explanatory Statement, will read substantially as follows except as otherwise may be set forth herein:

### **BOND PROPOSAL QUESTION NO. 1**

The Board of Education of the Township of Riverside in the County of Burlington, New Jersey is authorized (a) to undertake various improvements, alterations, renovations, and upgrades, and to construct an addition at Riverside Elementary School, including acquisition and installation of fixtures, furniture, equipment and any site work; (b) to undertake the replacement of the roof at Riverside Middle School and the replacement of a portion of the roof at Riverside High School, including all related work; (c) to appropriate \$15,866,036 for such improvements; and (d) to issue bonds in an amount not to exceed \$15,866,036. The Board may offset the amount of bonds to be issued with any state and/or federal funds or grants available at the time of the bond issuance.

The final eligible costs for the projects approved by the New Jersey Commissioner of Education are \$10,194,266 (consisting of \$6,294,266 for Riverside Elementary School, \$1,950,000 for Riverside Middle School and \$1,950,000 for Riverside High School). The project includes \$0 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 70.1104% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election.

### **BOND PROPOSAL QUESTION NO. 2**

(Bond Proposal Question No. 2 will only go into effect if Bond Proposal Question No. 1 is also approved by the voters at this election.)

The Board of Education of the Township of Riverside in the County of Burlington, New Jersey is authorized (a) to replace windows at Riverside High School, including any related work; (b) to appropriate \$975,000 for such improvements; and (c) to issue bonds in an amount not to exceed \$975,000. The Board may offset the amount of bonds to be issued with any state and/or federal funds or grants available at the time of the bond issuance.

The final eligible costs for the projects approved by the New Jersey Commissioner of Education are \$975,000. The project includes \$0 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 70.1104% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election.

### **EXPLANATORY STATEMENT**

At this election, the voters of the school district are being asked to consider both Bond Proposal Question No. 1 and Bond Proposal Question No. 2. As set forth above, Bond Proposal Question No. 2 will only go into effect if Bond Proposal Question No. 1 is also approved by the voters at this election.

These two proposals will authorize various improvements, alterations, renovations, and upgrades, and the construction of an addition at Riverside Elementary School, including acquisition and installation of fixtures, furniture, equipment and any site work, the replacement of the roof at Riverside Middle School, including any related work, and the replacement of a portion of the roof, and the replacement of windows at Riverside High School, including any related work. If both proposals are approved by the voters, the total cost of the projects will be \$16,841,036, and the Board will be authorized to issue bonds in an amount not to exceed \$16,841,036. The Board may further offset the amount of bonds to be issued with any additional state and/or federal funds or grants available at the time of the bond issuance. These combined proposals have a total final eligible costs approved by the New Jersey Commissioner of Education of \$11,169,266 (consisting of \$6,294,266 for Riverside Elementary School, \$1,950,000 for Riverside Middle School and \$2,925,000 for Riverside High School). The proposed improvements include \$0 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 70.1104% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election

2. The Board hereby approves and adopts the Proposals set forth above and, subject to the approval of the legal voters of the School District, hereby determines to carry out the same as described therein (the "Project"). The Board authorizes the Business Administrator/Board Secretary, consistent with any advice received from Bond Counsel (as hereinafter defined), to revise the proposals, and the explanatory statement, if necessary, prior to the Election to conform to any applicable legal requirements.

3. The Board hereby acknowledges and confirms that, in accordance with the requirements of N.J.S.A. 18A:24-16 and N.J.S.A. 18A:24-17, a Supplemental Debt Statement has been prepared as of the date of this resolution by the chief financial officer of the Township of Riverside, giving effect to the proposed total authorization of School Bonds of the School District in the maximum amount provided for in the Proposals, and that such Supplemental Debt Statement has been filed in the office of the municipal clerk, in the office of the Business Administrator/Board Secretary prior to the adoption of this resolution, and will be filed in the office of the Director of the Division of Local Government Services, State of New Jersey, Department of Community Affairs prior to the date of the Election.

4. The Business Administrator/Board Secretary is hereby authorized and directed, in conjunction with Bond Counsel, to deliver a certified copy of this resolution and such other information as shall be necessary to the County Clerk as required by N.J.S.A. 19:60-2, to request the County

Clerk to submit the Proposals, together with the Explanatory Statement, to the voters at the Election, and to seek the assistance of the county officials and the municipal clerk in conducting the Election.

5. The Board hereby: (i) accepts the determination of Preliminary Eligible Costs as set forth in the letter from the New Jersey Department of Education and not to appeal such determinations made therein; (ii) determines to construct the Project itself; (iii) agrees to locally fund any excess costs, if any; and (iv) delegates the supervision of the Project to the Business Administrator/Board Secretary.

6. Garrison Architects, the School District's appointed architect for the Project (the "Project Architect"), has heretofore been authorized and delegated the responsibility to prepare the plans and specifications for the Project in consultation with and under the supervision of the Business Administrator/Board Secretary, who has been delegated the responsibility to work with the Project Architect for this purpose on behalf of the Board, in accordance with the requirements of N.J.S.A. 18A:18A-16, and such authorizations and delegations are hereby reconfirmed.

7. The Superintendent, Business Administrator/Board Secretary and such other officers, professionals and agents of the Board as are necessary, including Wilentz, Goldman & Spitzer, P.A., Bond Counsel ("Bond Counsel"), and the Project Architect, are each hereby authorized and directed to perform such acts, execute such documents and do such things as are necessary and proper for the submission of the Proposals, together with the Explanatory Statement, to the voters of the School District at the Election.

8. This Board hereby makes the following covenants and declarations with respect to obligations determined to be issued by the Business Administrator/Board Secretary through a public offering or private placement or through a conduit borrower on a tax exempt basis. The Board hereby covenants that it will comply with any conditions subsequent imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of interest on its bonds or notes if issued as tax exempt, including, if necessary, the requirement to rebate all net investment earnings on the gross proceeds above the yield on its bonds or notes.

The Business Administrator/Board Secretary is hereby authorized to act on behalf of the Board to deem the obligations authorized herein as bank qualified for the purposes of Section 265 of the Code, when appropriate. The Board hereby declares its intent to issue bonds or notes in the amount set forth in the Proposal approved by the voters as set forth in Section 1 and to use the proceeds to pay or to reimburse expenditures for the costs of the Project authorized herein. This resolution is a declaration of intent within the meaning and for the purposes of Treasury Regulations 1.150-2 or any successor provisions of federal income tax law.

9. This resolution shall take effect immediately.
